### **1. PRODUCT DESCRIPTION:**

#### **TEROSON PU 6700**

Two-components polyurethane adhesive (mixing ratio 1:1) with about 50% calcium carbonate.

Maximum surface weight: 270 g/m<sup>2</sup>.

Tested color: black

### **4. APPLICATION / LIMITATION:**

4.1 - Restricted application: adhesive **TEROSON PU 6700** is to be used in floor coverings or primary deck coverings applications only, with a maximum application rate of 270 g/m<sup>2</sup>.

4.2 - Approved material is considered as having low flame spread characteristics (as per IMO 2010 FTP Code Part 5) and not producing excessive smoke and toxic products (as per IMO 2010 FTP Code Part 2).

### **5. PRODUCTION SURVEY REQUIREMENTS:**

5.1 - This certificate alone does not allow the applicant to issue the Declaration of Conformity and to affix the mark of conformity (wheelmark) to the products corresponding to this type. To this end, the production-control phase module D Production Quality Assurance or module E Product Quality Assurance or module F Product Verification of Annex II of the Directive is to be complied with and controlled by a written inspection agreement with a Notified Body.
